ASSUMPTION OF RISK & WAIVER FORM

I also expressly waive and covenant not to sue on any claim I might have against the Danville Soccer Club's Recreational League, City, or any officer or employee of the League, City, or any volunteer, or the estate or representatives of such persons for any personal injury or loss I might sustain as a result of engaging in any activity relating to this program whether cause by negligence, breach of contract or otherwise; except that this waiver shall not apply to any claim I might have against the League and/or City (or its agents) for any such personal injury or loss I might sustain arising out of the gross or wanton negligence of any such persons or entity.
